Dear Adult Students of Center Place,

Center Place Fine Arts is pleased to announce that the month of **April 2019** will be hosting our annual "**Center Place Adult Student Fine Arts Show**" to exhibit art work by our students.

Guidelines

- All **2D** work to be placed on exhibit must be framed and wired for hanging (no saw tooth hangers).

All 2D Media is not to exceed 40" in any dimension, including frame. No GICLEE or copies of any kind.

Works on paper should be matted and under glass or Plexiglas.

Gallery wrap canvas must have screw eyes between stretchers with wire loose enough to lay flat.

***Without proper framing and wiring-works will not be accepted**

- All **3D** artwork in traditional medium, including fiber, ceramics, metal, jewelry, glass and wood is not to exceed 18"H x 10"W x 12"D, with a weight limit of 3 lbs.
- Two (2) works may be submitted by each student per instructor and do not need to have been done in class.
Center Place requests that students from the same instructor not exhibit the same pieces.

***Nudes and religious work will not be accepted**

***Wet paintings will not be accepted**

- Center Place will coordinate publicity for the exhibit.
- Center Place will sponsor the reception for the exhibit, which is hosted by the Brandon League of Fine Arts on Thursday, April 11, 2019 from 5:30-7:00 pm.
- Center Place does not charge a commission on artwork sold during the exhibit. However, any donation you wish to make when your work is sold would be most welcome to help defray the cost of the exhibit. (30% donation is suggested)
- The artist is responsible for delivery and pick up of their work for the exhibit on the designated date and time. **On delivery include TWO copies listing the work with titles, media, sale price, and insurance value (cost of material & framing only). See forms attached.**

Delivery Date: Monday, March 25th - Thursday, March 28th 9:00 am-5:00 pm

Pick-up Date: Monday, April 29, 2019 9:00 am-5:00 pm

Center Place will assign a qualified Hanging Committee (BLFA) to hang the exhibit. The final decision of the hanging of the exhibit is up to said Committee.

ALL pieces must remain at Center Place during the entirety of the exhibit.
