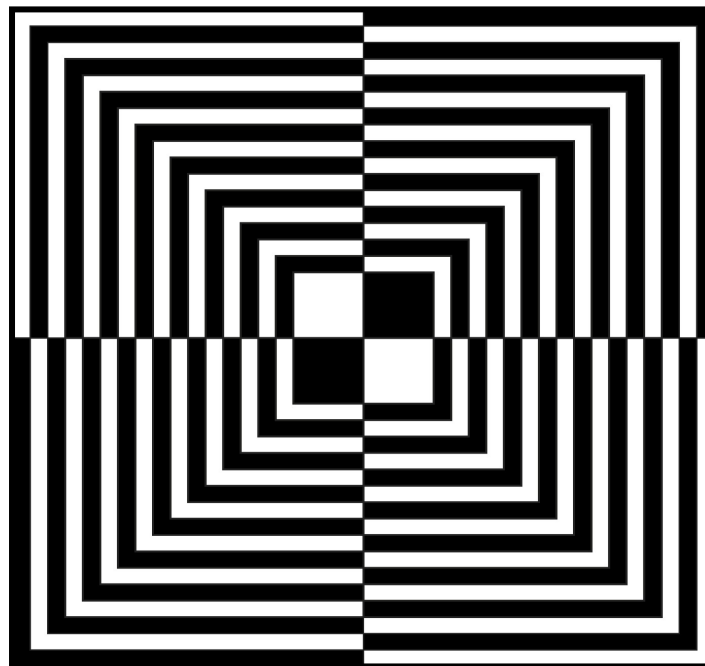

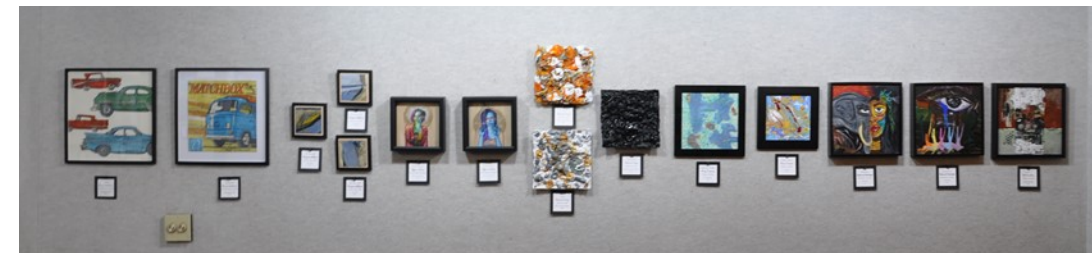

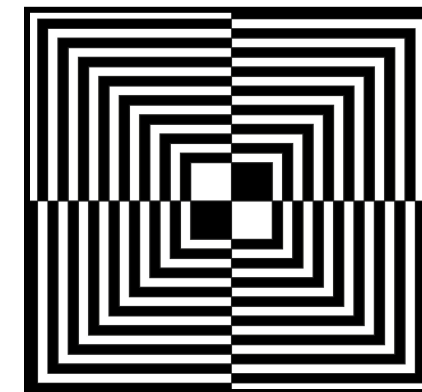

## Entry Fee

There is a \$35 non-refundable fee for up to (3) entries.

## Sales

A 30% commission will be retained from all work sold during the exhibition. **All work must be available for sale.**

## Eligible Media

**All entrees must be SQUARE.** They may not weigh more than 5 pounds. Work size must be a minimum of 5" x 5" and a maximum of 24" x 24". All frames must be smooth and black with no carvings on frame and be **wired** for hanging, including gallery wrapped canvases. Works on paper should be under plexi-glass, matted and framed. All works must be able to hang on the exhibit wall. **NO SAWTOOTH HANGERS** will be allowed.

**All** 3D work must be square and meet the above size and weight requirements and be able to hang on the exhibit wall.

Entries must be the complete work of the submitted artist. Kits, prints or commercially designed works will not be accepted. All work must be original and have been completed within the past 2 years and not previously exhibited at Center Place Fine Arts. Artists must reside within the 48 Contiguous United States.

**No nudes or religious pieces will be accepted.**



## Digital Images

Digital images should be in a jpg format of at least 300 dpi. (Framing is not required until artwork is juried, all items will need to be framed for the exhibition.)

## Digital File Labeling

Digital images must be labeled as follows: lastname\_firstinitial\_titleofwork\_medium.jpg  
Example: Smith\_A\_thelanding\_acrylic.jpg  
Please include size of work for each piece.

## Liability

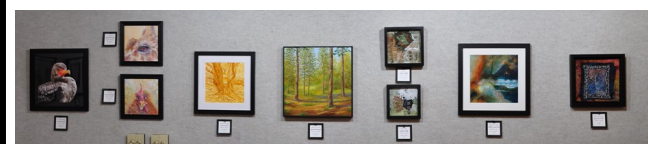
Entries will be insured by Center Place Fine Arts while in its custody provided that the artist has declared an insurance value not to exceed 50% of the selling price.

## Agreement

No work may be withdrawn before the close of the exhibition. Sending an entry to this exhibition shall imply an agreement on the part of the sender to all conditions above.

## Publicity

The exhibition will be publicized regionally & nationally. Center Place Fine Arts reserves the right to photograph any accepted work for the purpose of publicity.



## Awards

Center Place Fine Arts will provide Juror Awards in the amounts of \$500, \$250, \$100 & \$50. Winners will be determined by the juror, on site. Winners will be announced at the Artist Reception, Friday, February 7, 2020 from 6-8 pm.

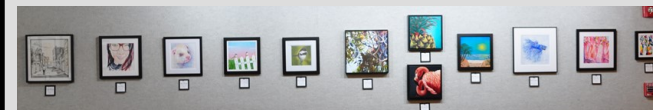
